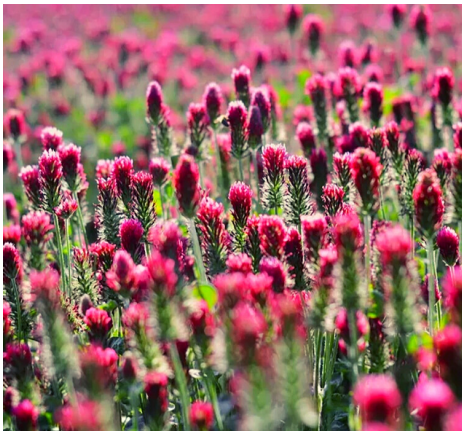

She’s an Everest summiteer and first woman to skydive Everest, who has fundraised > £400K.
