Health Protection (Coronavirus) (International Travel and Operator Liability) (Scotland) Regulations 2021 (SI 2021/322)

In Force - 20 September 2021

These Regulations consolidate, with amendments, the Health Protection (Coronavirus) (International Travel) (Scotland) Regulations 2020, Health Protection (Coronavirus, Public Health Information for Passengers Travelling to Scotland) Regulations 2020 and Health Protection (Coronavirus) (Pre-Departure Testing and Operator Liability) (Scotland) Regulations 2021.

Health Protection (Coronavirus) (International Travel) (Scotland) Amendment (No. 19) Regulations 2021 (SSI 2021/319)

In Force - 15 September 2021

These Regulations amend the Health Protection (Coronavirus) (International Travel) (Scotland) Regulations 2020 to provide an exemption from the requirement to take out and adhere to a managed self-isolation package under regs 6A and 6B of those Regulations in respect of participation in European professional football club fixtures in Scotland where players in the professional club arriving to play the fixture have departed from or transited through an acute risk country or territory within the preceding 10 days.

Health Protection (Coronavirus) (International Travel) (Scotland) Amendment (No. 17) Regulations 2021 (SSI 2021/301)

In Force - 6 September 2021

These Regulations amend the Health Protection (Coronavirus) (International Travel) (Scotland) Regulations 2020, which currently provide that coronavirus day 2 and day 8 tests must be carried out by public providers, i.e. by the NHS in Scotland, England and Wales, and Northern Ireland. These amendments (regs 3 and 4) open up those tests to private sector test providers, provided they are on a UK Government published list of day 2 and day 8 test providers for persons arriving in England. To get on the list, the providers must self-declare compliance with relevant regulations and Department of Health and Social Care (DHSC) guidance. The listed providers are also monitored by DHSC for compliance, and if in default removed from the list. The 2020 Regulations also provide that travellers to Scotland must stay in specified premises. These amendments (regs 5 to 7) amend an exemption for seasonal agricultural workers in Sch.2 para.37 of the 202 Regulations. Unamended, 2020 Regulations make clear that those to whom the exemption applies must self-isolate at the named farm where they will be working after arrival in Scotland. The amendments in these Regulations allow these workers to alternatively self-isolate in other accommodation provided by the farm or employer. The amendments make clear that those workers staying at the alternative accommodation are not permitted to work on the named farm before the end of their isolation. Health Protection (Coronavirus) (International Travel) (Scotland) Amendment (No.16) Regulations 2021 (SSI 2021/290)

Coronavirus (Extension and Expiry) (Scotland) Bill

The Bill was passed on 24 June 2021 and became an Act on 04 August 2021

To help manage the COVID-19 pandemic, the Scottish Parliament passed two Bills in 2020. These became the Coronavirus (Scotland) Act 2020 and the Coronavirus (No.2) (Scotland) Act 2020 ("the Scottish Acts"). The changes to the law in Part 1 of each of these Acts are due to expire on 30 September 2021.

Health Protection (Coronavirus) (International Travel etc.) (Miscellaneous Amendments) (Scotland) (No. 7) Regulations 2021 (SSI 2021/278)

In Force - 8 August 2021

These Regulations amend the Health Protection (Coronavirus) (International Travel) (Scotland)Regulations 2020 ("the International Travel Regulations") and the Health Protection (Coronavirus)(Pre-Departure Testing and Operator Liability) (Scotland) Regulations 2021 ("the Operator LiabilityRegulations").

Health Protection (Coronavirus) (Requirements) (Scotland) Regulations 2021 (SSI 2021/277)

In Force - 9 August 2021

These Regulations set out continuing requirements which apply in Scotland as a result of coronavirus and revoke the Health Protection (Coronavirus) (Restrictions and Requirements) (Local Levels) (Scotland) Regulations 2020.

Health Protection (Coronavirus) (International Travel) (Scotland) Amendment (No.15) Regulations 2021 (SSI 2021/275)

In Force - 31 July 2021 : 2 August 2021

These Regulations amend the Health Protection (Coronavirus) (International Travel) (Scotland) Regulations 2020 to exclude certain arrivals from non-exempt but not acute risk countries or territories from certain testing and self-isolation requirements.

Health Protection (Coronavirus) (International Travel etc.) (Miscellaneous Amendments) (Scotland) (No. 6) Regulations 2021 (SSI 2021/265)

In Force - 19 July 2021

These Regulations amend the Health Protection (Coronavirus) (International Travel) (Scotland) Regulations 2020. They exclude passengers who have departed from, or transited through mainland France (including Corsica), from status as "eligible vaccinated arrivals" within the meaning of reg.2A of those Regulations, who would have been exempt from certain requirements imposed by the Regulations. They also remove the duty on an operator of a relevant service which commences in France to check that such a passenger possesses the required evidence.

Scottish Government want emergency COVID-19 restriction laws to become permanent

The Scottish Government wants its emergency coronavirus powers to become permanent, including the ability to order schools to close, impose lockdowns and use online courts. Ministers are seeking the public's views on removing a March 2022 expiry date, with John Swinney, the deputy first minister, arguing that some of the changes have had a "demonstrable benefit".

Reg.3 amends the Health Protection (Coronavirus) (Restrictions and Requirements) (Local Levels) (Scotland) Regulations 2020 Sch.3, which sets out restrictions applying in Level 2 areas. Sch.3 para.11 sets out restrictions on public gatherings indoors in Level 2 areas. The amendment is to the effect that gathering is permitted in Level 2 areas for the purpose of organised activity involving persons of any age (organised activity is defined in para.11(3)). Reg.4 amends Sch.7 of the 2020 Regulations to add a new exception to the requirement to wear a face covering in certain indoor places. The effect of the amendment is that, in certain circumstances, a person does not require to wear a face covering in a place mentioned in Sch.7 para.3 if they are receiving a close contact service that requires access to the area covered by a face covering.

Coronavirus (Scotland) Act 2020 (Early Expiry of Provisions) Regulations 2021 (SSI 2021/214)

In Force 30 June 2021

These Regulations expire the Coronavirus (Scotland) Act 2020 Sch.7 paras 19 and 31 on 30 June 2021.

Health Protection (Coronavirus) (International Travel) (Scotland) Amendment (No. 11) Regulations 2021 (SSI 2021/212)

In Force 25 May 2021

These Regulations amend the Health Protection (Coronavirus) (International Travel) (Scotland) Regulations 2020. Reg.3 amends reg.7A of the 2020 Regulations to limit the exemption of seafarers and inspectors and surveyors of ships from the requirement to enter Scotland only at a designated port and the requirement to take out and comply with a managed self-isolation package (hotel accommodation, transport to it and testing). Seafarers and inspectors and surveyors of ships will no longer benefit from the exemption where they have entered the UK in order to work on a cruise ship, or after having worked on a cruise ship. Reg.4 makes saving provision such that a person who arrives in Scotland on or after 12:01 am on 8 June 2020, but before the coming into effect of an amendment made by these Regulations, must comply with the 2020 Regulations as they were at the time at which the person arrived in Scotland.

Health Protection (Coronavirus) (Restrictions and Requirements) (Local Levels) (Scotland) Amendment (No. 24) Regulations 2021 (SSI 2021/211)

In Force 22 May 2021 : 24 May 2021

These Regulations amend the Health Protection (Coronavirus) (Restrictions and Requirements) (Local Levels) (Scotland) Regulations 2020. Reg.3 amends Sch.6 of the 2020 Regulations to the effect that, from 22 May 2021, Level 2 restrictions apply in the Moray local government area. Further amendments are made to the Health Protection (Coronavirus) (International Travel) (Scotland) Regulations 2020 which impose requirements on international travellers, to reduce the public health risks posed by the spread of coronavirus (severe acute respiratory syndrome coronavirus 2, or SARS-CoV-2) in Scotland which causes the coronavirus disease (COVID-19). It removes the United Arab Emirates from the list of exempt countries or territories in schedule A1. Persons arriving in Scotland are not subject to the requirement in regulation 6 of those Regulations for travellers to stay in specified premises if, during the 10 days preceding their arrival they have only been in exempt countries or territories or exempt UK overseas territories in Scotland. These Regulations came into force on at 4.00 am on 12 January 2021.

Scotland in lockdown

Scottish Government

5 January 2021

The Scottish Government has announced that Mainland Scotland is to go into lockdown from midnight on 5 January 2021 with a new legal requirement forbidding anyone from leaving their home except for essential purposes. Amongst the limited reasonable excuses to leave your home are provisions for caring, outdoor exercise and to go to work, but only if that work cannot be done from home. In a statement to Parliament, the First Minister said a steep increase in coronavirus (COVID-19) infections and the intensity of pressure on the NHS have created a race between the virus and the vaccines now coming online. As a result, she said it was now imperative that everyone should comply with the message to "Stay at Home" for the duration of January.
